



Long-Side (50% Optimus VA Core Equity): Seeks to provide investors with the capital appreciation normally associated with a U.S. mix of equities, while maintaining the ability to move to fixed income for downside risk protection. This long-only model can vary its equity investments from 0% to 100% of the portfolio, using monthly and quarterly rotations. 50% of the strategy is comprised of two monthly rotation sub-strategies. The other 50% of the strategy is comprised of two quarterly rotation sub-strategies.

Short-Side (50% Optimus VA Advantage): Seeks to provide investors with an opportunity for gains during U.S. equities and U.S. Govt. bond market declines. The strategy uses five inverse funds that are based on U.S. equities and U.S. Govt. bonds.



Historical Performance 01/01/2007–01/31/2017




