Optimus Global Rotation: Seeks to provide investors with the capital appreciation normally associated with a global mix of equities, while maintaining the ability to move to fixed income for downside risk protection. This long-only ETF model can vary its equity investments from 0% to 100% of the portfolio, using monthly and quarterly rotations with an annual rotation overlay.

Historical Performance 01/01/2000–05/31/2017



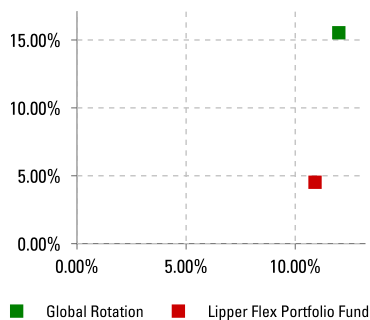
