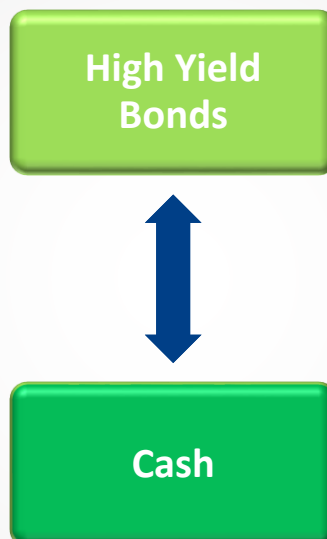
GROWTH THROUGH HIGH YIELD BONDS

- Diversified exposure to high yield bonds when high yield bonds are in an uptrend

BUILT-IN RISK MANAGEMENT

- Moves the portfolio to cash when the uptrend in high yield bonds is over

Optimus VA Tactical High Yield: Seeks to provide investors with the total return normally associated with High Yield Bonds, while using optimal exit techniques for downside risk reduction. The program was designed around a high yield bond fund index, but uses variable annuity sub-accounts as the actual investment vehicles. There are two independent signals for a maximum of one long position. All independent signals vary from short-term to long-term in nature. Stop losses and trailing stops are used.



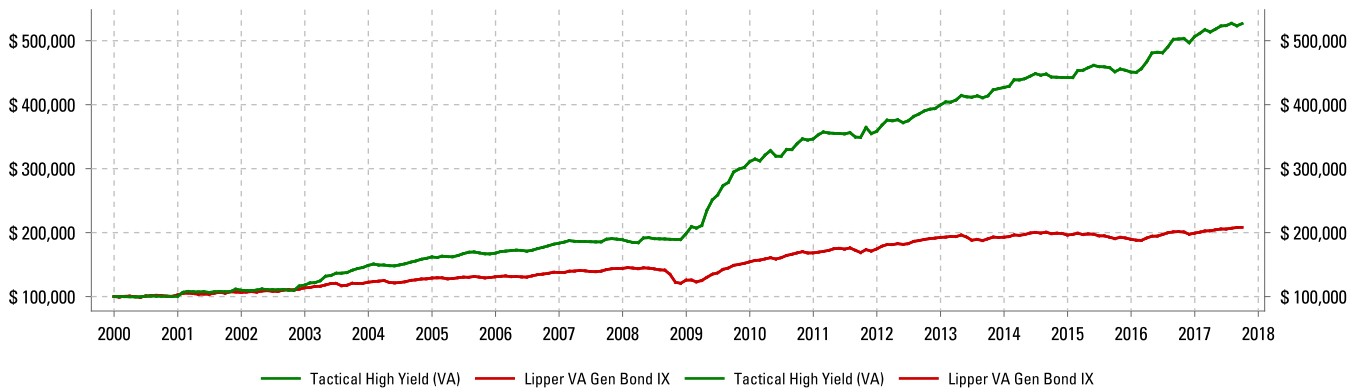

Historical Performance 01/01/2000–09/30/2017



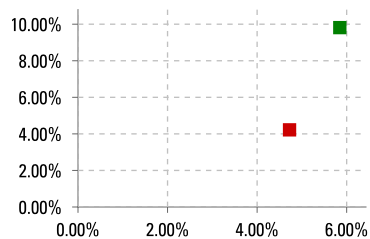
